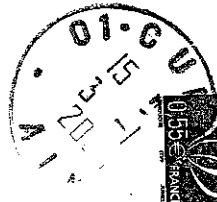

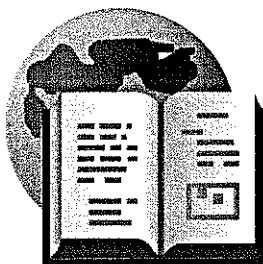

Further to my Report of December 21st, which dealt with Council's concerns about materials on or related to the IUE server, Council has made a determination on the matters set out in that Report.

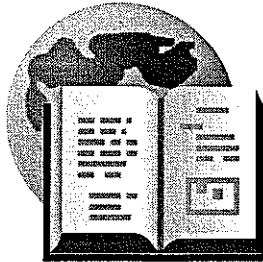
It is the decision of Council that your membership of The World Wide Web Virtual Library be suspended forthwith.

Sir,

I was aware, when I wrote to you on Tuesday, that what could be interpreted as a request to resign your membership of The World Wide Web Virtual Library, still remained unanswered from your email of December 21st. You have now (and in *such* prose) reminded me of this point in your email of this morning.

You will I hope forgive me for proceeding in a logical and purposeful manner —the WWWVL would also like to see a closure of these matters. My letter of earlier this week was dealing with questions originally raised in *October* and which however little time you actually spend in your office (statements in your email of December 21st) were actually sent to you by email as well as by courier in that month. Having closed that matter, let us now turn to your 'request' of December 21st.

I will put this request to Council. ***If you wish to assist me in putting your case***, it would be of the utmost assistance if I could report that you had stopped using the WWWVL's logo on your site and that you had otherwise stopped any actions which could be taken as indicating that your site is a part of the WWWVL.

I would request that you re-read Tuesday's letter. The WWWVL hopes for an amicable resolution of these problems: The tone of this morning's email (how many years of full-time education do you have?) hardly makes one optimistic, but I would request that you ***do*** try. No-one forced you to join the WWWVL. There is no bar on your seeking to leave the WWWVL, but you are not allowed to take the WWWVL's property with you when you go


